In 2022 DAPEEP has decided to move from their own original solution and start searching for an existing and reliable product covering all necessary functionalities related to GO's issuing and further management of the certificates that's also offered in Software as a Service mode. The desired solution needed to satisfy the increasing demand for high performance, reliability and scalability since the numbers of both the issued certificates and the consecutive transactions are continuously increasing.

Certigy Registry met all crucial requirements set by DAPEEP and so we are proud to announce that Unicorn Systems has delivered and operates DAPEEP's new registry, Certigy Registry, since December 2023. The registry currently supports European EECS GO standard for electricity guarantees of origin (GO's) and the main features of the solution are:

- Management of large number of production devices
- Issuance of Guarantees of Origin (including for High-Efficiency Cogeneration stations)
- International transfers (via AIB Hub)
- Retirement of Guarantees of Origin
- · Availability of Certigy Registry API for Issuing Body
- User Management
- Localization to Greek language (including Greek specific font)

Delivered system was also already audited for v80 scheme (new EECS GO format) and was connected to the AIB Hub simultaneously in December 2023 allowing both exports from Greece and imports of GO's to Greece.
